We understand that the Expo director reserves the right to demand release of rooms or booths at any time during the Expo if our representatives fail to conform to the rules and regulations. In the event of cancellation of Expo due to fire, strikes, governmental regulations or other causes beyond our control, the Director shall determine an equitable basis for refunds after consideration of expenditures and commitments already made. Fees are not refunded for any other reason. On behalf of Citrus Road Runners Club, Inc., DRC Sports, a division of Direct Response Communications Inc., its officers and agents will not under any circumstances be responsible for any loss sustained by any exhibitor or any other person by reason of fire, theft, water, accidents or any cause or reason but will use reasonable care to protect the exhibitor from such loss.

Exhibitors should affect their own insurance. It is agreed that each exhibitor shall assume responsibility for damage to the property and shall indemnify and hold blameless Citrus Road Runners Club and DRC Sports for all liability which might ensue from any cause whatsoever, including accidents or injuries to exhibitors or employees.

SPACE ASSIGNMENT: DRC Sports reserves the right to make all space assignment in the best interest of the total Expo. Any exhibits that in the opinion of DRC Sports Expo Coordinator have been misrepresented or deemed objectionable may be rejected. No booth space may be sub-leased or sold to another vendor.

CONDUCT: All exhibits must remain open and all exhibitors must wear their identification badge during Expo hours.

BOOTH SETUP/DISMANTLE: Booth set up will be as specified in Expo information. There will be no display of merchandise in aisles or outside of the assigned space unless cleared by the DRC Sports Expo Coordinator. Booths may be dismantled after closing time on the day of the Expo. Exhibitors removing displays or merchandise prior to that time (unless cleared by the Expo Coordinator) will not receive contracts for future Expos. Any disputes over space, set-up, times etc. will be taken up with the DRC Sports Expo Coordinator only.

EQUIPMENT FURNISHED: We furnish at no extra charge per booth: 1 draped table and 2 chairs. Additional tables are available for a fee. Each exhibitor will be given two tickets for the pre-race past dinner at the Host Hotel.

SPECIAL NOTICE- Every exhibitor is responsible for any damage caused to the exhibit hall. **Do NOT pin, stick, or tape anything to walls.**

ANY VIOLATION OF THESE RULES SHALL ENTITLE THE EXPO COORDINATOR TO CLOSE THE EXHIBITOR'S DISPLAY FOR THE DURATION OF THE EXPO.
